# General Certification Program Updates

# Revised Version 4.0 Transition Policy

## Products currently certified to Version 3.1:

- Companies may apply for certification to Version 4.0 for products certified to Version 3.1 as of 1 July 2021 (the Version 4.0 Effective Date). **All Version 4.0 certifications will be valid for three years.**
- Products that were initially certified or last recertified prior to 16 November 2022 may recertify to Version 3.1 one additional time until **31 December 2024**. Assessment summary forms for these Version 3.1 recertifications will be accepted until 31 December 2024. Products must then be recertified to Version 4.0 when the Version 3.1 certification expires.
- All Version 3.1 certifications will be valid for two years. Certifications previously issued in 2022 for less than two years will be extended to allow for a two-year certification period.

# Update to Program Fee Schedules

## **Effective 1 May 2023: All program fees listed in US Dollars only**

- Companies previously receiving invoices in Euros will receive invoices in U.S. Dollars and the company's currency conversion rate at the time of payment will apply
- Changes are effective 1 May 2023 for new Cradle to Cradle Certified® and C2C Certified Material Health Certificate™ applications.
- For re-certifications, changes will apply to all Cradle to Cradle Certified® certifications and C2C Certified Material Health Certificates™ with an expiration date of 1 August 2023 and after.

# Alternate RSL Compliance Pathways – Details

## SUPPLIER RSL DECLARATIONS and BILL OF MATERIALS DOCUMENTS

- For suppliers not able to sign C2CPII's RSL declaration or BoM Form, C2CPII accepts documents from suppliers in their own format.
- To be accepted, the supplier documents must:
  - Be on their company letterhead.
  - Include the same information required in C2CPII's RSL declaration OR BoM Form.
  - Use the same attestation/declaration language as C2CPII's forms\*.
  - Be signed by an appropriate company representative with the relevant knowledge, responsibility, and authority. Physical signatures are preferred, legally binding electronic signatures are accepted (e.g., Acrobat Sign, DocuSign).
  - Note: Language included that is not on the C2CPII form will need to be reviewed to determine conformance.

\* If suppliers have issues with C2CPII required language, then please let us know so we may address.

\*\* Supporting information will be added to the Version 4.0 User Guidance when updated later this year.



# Percentage Assessed Requirement – Challenges

## NOTES:

- Material Health Section 4.4 - Assessing Chemicals and Materials requires a threshold percentage of certified products to be assessed beginning with 75% at Bronze.
- C2CPII has been made aware of General Assessor challenges with this requirement due to:
  - Complexity of determining percentage assessed by the lower of: percentage assessed by weight OR percentage assessed by number of chemicals.
  - Unreasonable effort for supply chain engagement (even for Bronze Achievement Level).
  - Lack of supply chain transparency (especially for complex product groups).
- C2CPII is working on this issue and is interested in additional input from other General Assessors (send input to [chelt@c2ccertified.org](mailto:chelt@c2ccertified.org)).

# Using V4.0 forms in V3.1 assessments

Please note that the following data worksheets and forms developed for Version 4.0 assessments cannot be used in V3.1 assessments:

- Cradle to Cradle Certified Version 4.0 Supplier Restricted Substances Declaration
- Cradle to Cradle Certified Version 4.0 Supplier CMR & SVHC Declaration

These V4.0 forms do not cover all requirements of the relevant V3.1 requirements. In general, it is advised to not use V4.0 forms in V3.1 assessment and vice versa. Exceptions include when a V3.1 assessment includes one or more categories assessed to V4.0

# Site Visits and the C2CPII COVID Site Visit Policy

- The COVID-19 site visit policy, implemented more than two years ago, was phased out on 30 June 2022.
- Please ensure that the required site visits have been conducted for all Version 3.1 for that constitute provisional certifications for which the site visit was waived due to the covid site visit policy and Version 4.0 assessments before they are submitted to the Institute.
- If any issues are still being encountered with conducting the required site visit(s) due to mandated travel restrictions (e.g., China), please let us know prior to submitting the assessment summary for these applications so we can work with you and determine how to proceed.
- **Currently remote site visits cannot replace on-site visit**

# Initial V3.1 certifications

- Applications and assessment summary forms for new product certifications to Version 3.1 will be accepted from existing Version 3.1 certification holders until 31 December 2023.
- It will not be permitted to certify products ineligible for Version 4.0 certification to Version 3.1 unless it is possible to demonstrate a commitment to meet the Version 4.0 requirements within a certain timeframe
- Products may be added to an existing Version 3.1 certification (in accordance with the product grouping policy) after the new product application deadline (31 December 2023) and through 31 December 2024.
- Companies applying for product certification for the first time are required to certify to Version 4.0.

# Completing the V4.0 ASF

- In the “Assessor Verification” section, assessors are required to please provide further comments and explanations about how a requirement was met in column “K”

- OEKO-TEX 100
  - Bronze Level Material Health Standards Section 4.4, testing for pesticides requirement

## Version 4.0 C2CPII-Recognized Certification Programs and Standards

This document lists currently recognized standards and programs. Please see the Version 4.0 User Guidance for recognized test methods (e.g., OECD, ISO, EN and similar tests).

# New C2CPII-Recognized Programs

C2CPII is currently evaluating several additional high priority programs for provisional recognition:

- PEFC (will be completed this week)
- Better Cotton Initiative (BCI) – (reevaluation)
- Global Organic Textile Standard (GOTS) - for potential extension of current recognition
- Sustainable Fiber Alliance (SFA)
- Global Recycled Standard & Recycled Claim Standard, Textile Exchange

# New C2CPII-Recognized Programs

Please note that recognition is only applicable for achieving very specific requirements as stated in the Version 4.0 standard. Requirements or parts of requirements that can be met by showing certification to a C2CPII-recognized certification program are marked as such in the V4.0 guidance document.

We welcome your suggestions for programs to recognize. When submitting such a request, please let us know specifically which of the Cradle-to-Cradle Certified requirements the other standard is relevant to.

Please note that these must be made to requirements that are already specified as requiring a C2CPII recognized standard.

For requirements that are currently not listed as capable of being met through other certification programs the process of recognition is currently long.

# Product descriptions

Product descriptions that are to be published on the C2CPII Certified products and materials registry must follow the Guidelines for Product Listings (Aug 2022):

- In general, promotional language (“first of its kind,” “best performing,” etc.) and environmental/sustainability, performance, or health claims are not permitted.
- However, claims that are associated with the certification and have been verified (e.g., through testing, such as biodegradability) can be communicated by indicating that the product(s) is (are) e.g., “designed to be biodegradable”.

# Verifying FSC-certified materials

FSC certified material is verified through the listing of FSC claims on sales documentation such as:

- Invoices from FSC certified supplier
- Delivery documentations such as
  - Packing lists
  - Delivery slips
  - Bill of ladings

Applicable FSC claims must be clearly linked to the material listed on the sales documentation and suppliers must have a valid FSC certificate

# Verifying FSC-certified materials

Current FSC claims:

- FSC 100%
- FSC Mix x% ( $1 \leq x \leq 100$ )
- FSC Recycled x%
- FSC Mix Credit
- FSC Recycled Credit
- FSC Controlled Wood

Evidence, that the supplier of FSC certified material is certified to relevant FSC standards is not sufficient, as these organizations can also sell uncertified material.

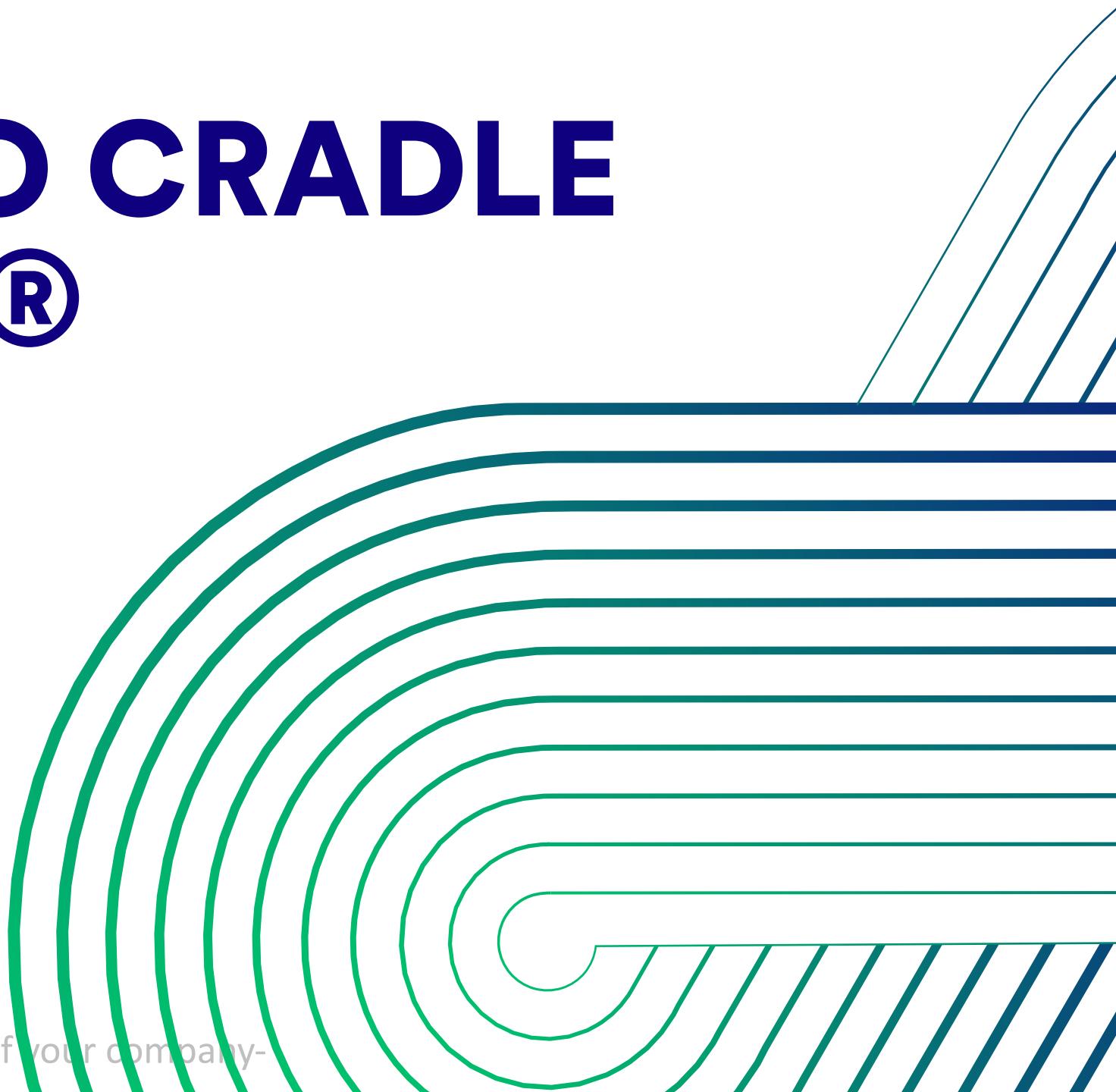

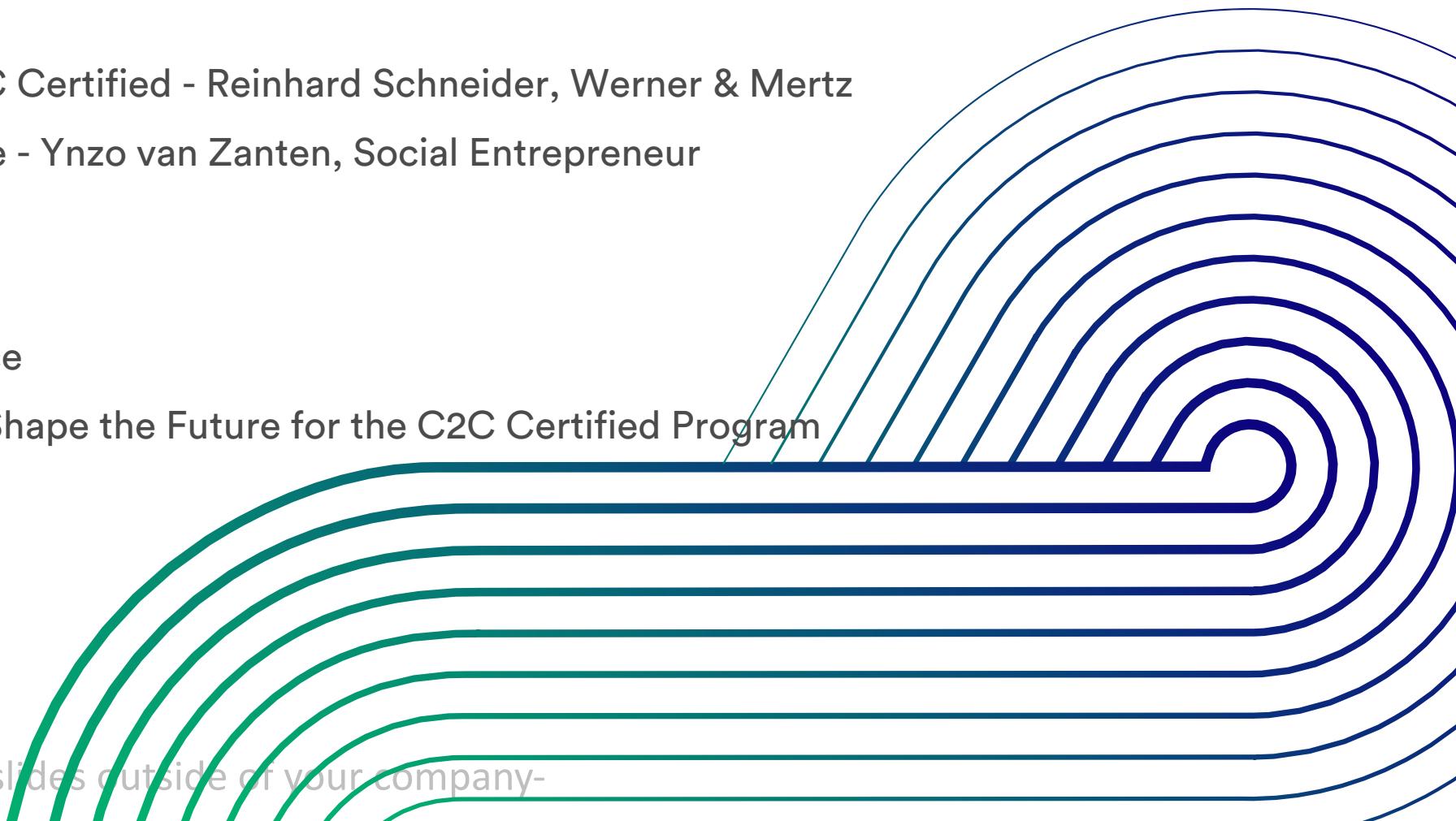

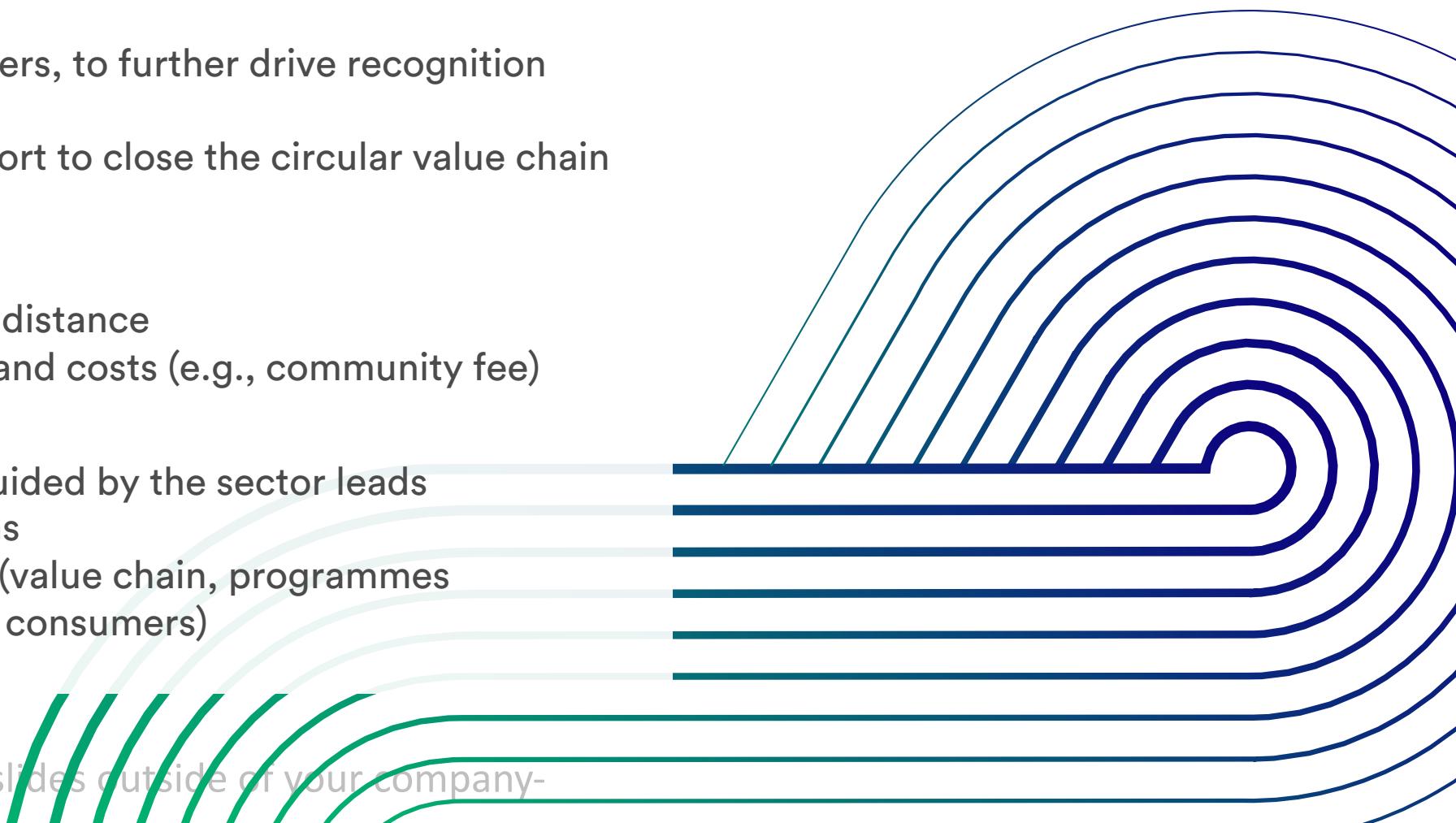
