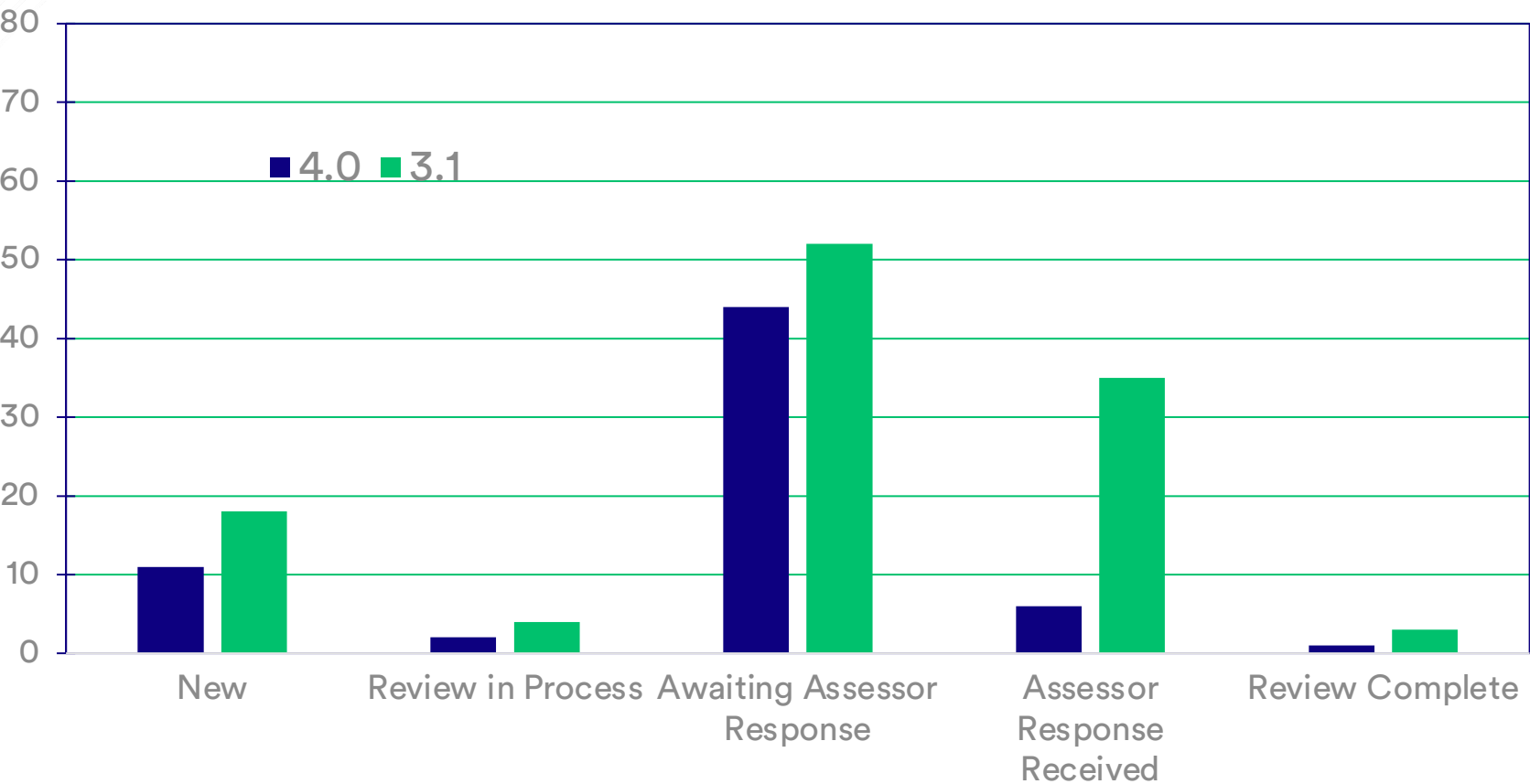

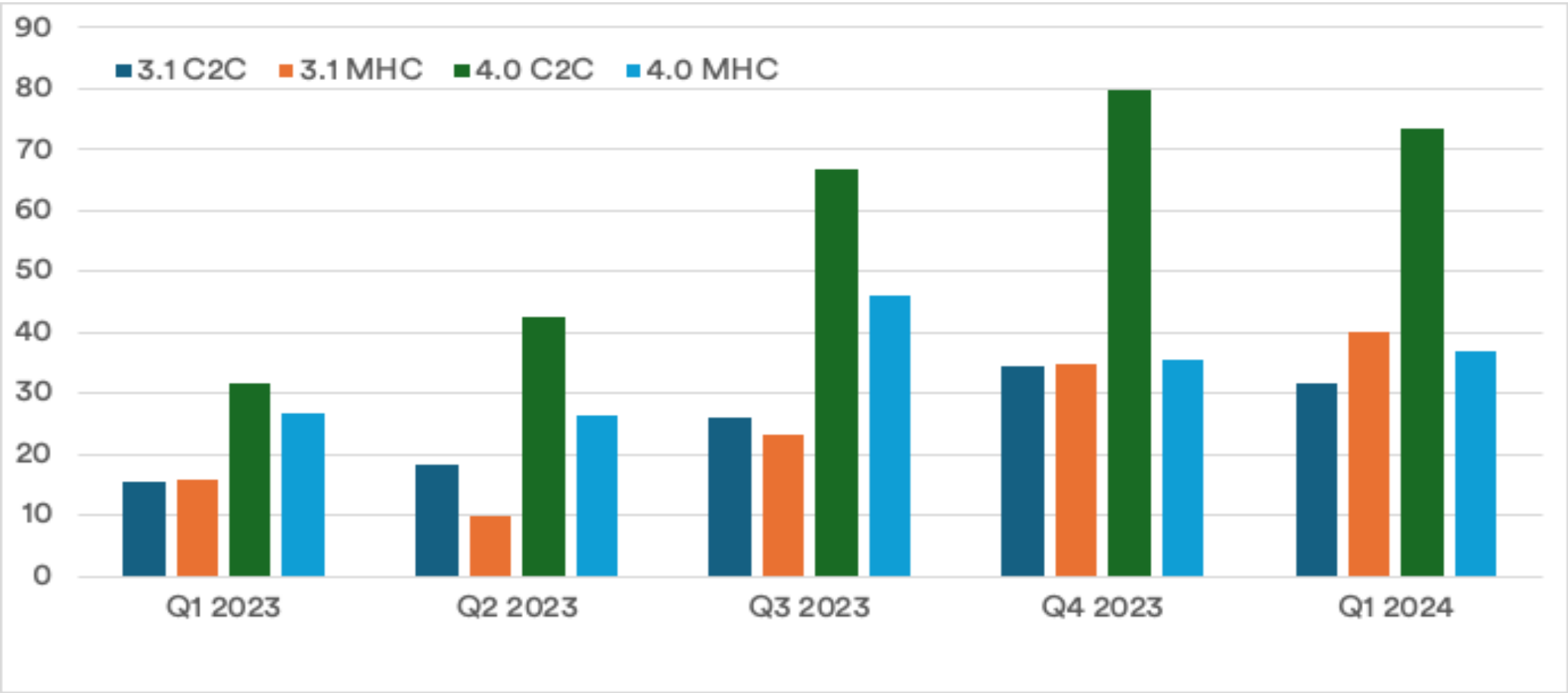

Initial Review Times

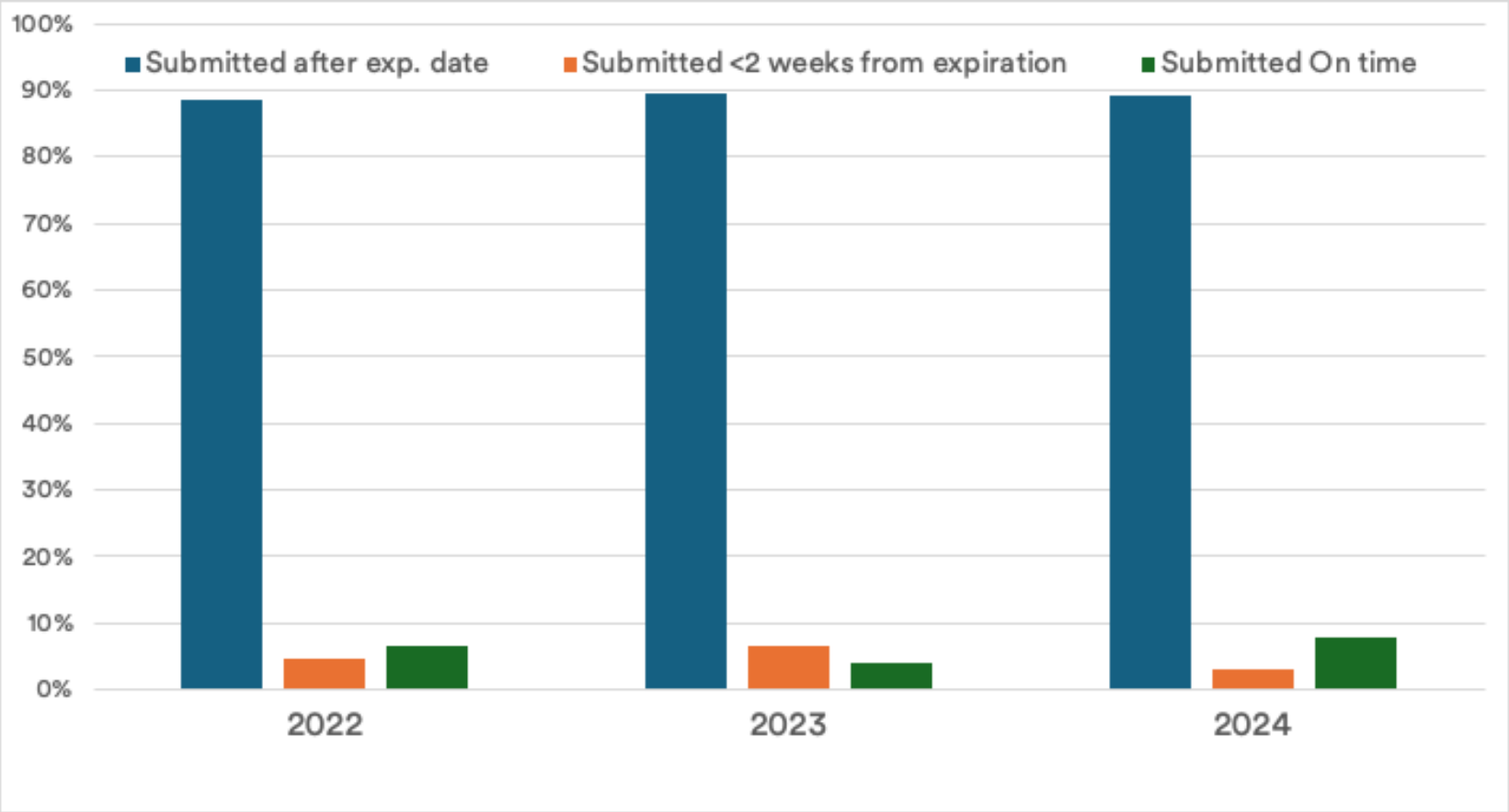
For all ASFs (new and recertifications, not PLCs or IARs) submitted from April 1, 2023 until April 1, 2024 the **average time to send initial comments** from C2CP II is:

- 27 days for V3.1 (Full C2C: 27, MHC: 26)
- 54 days for V4.0 (Full C2C: 71, MHC: 38)



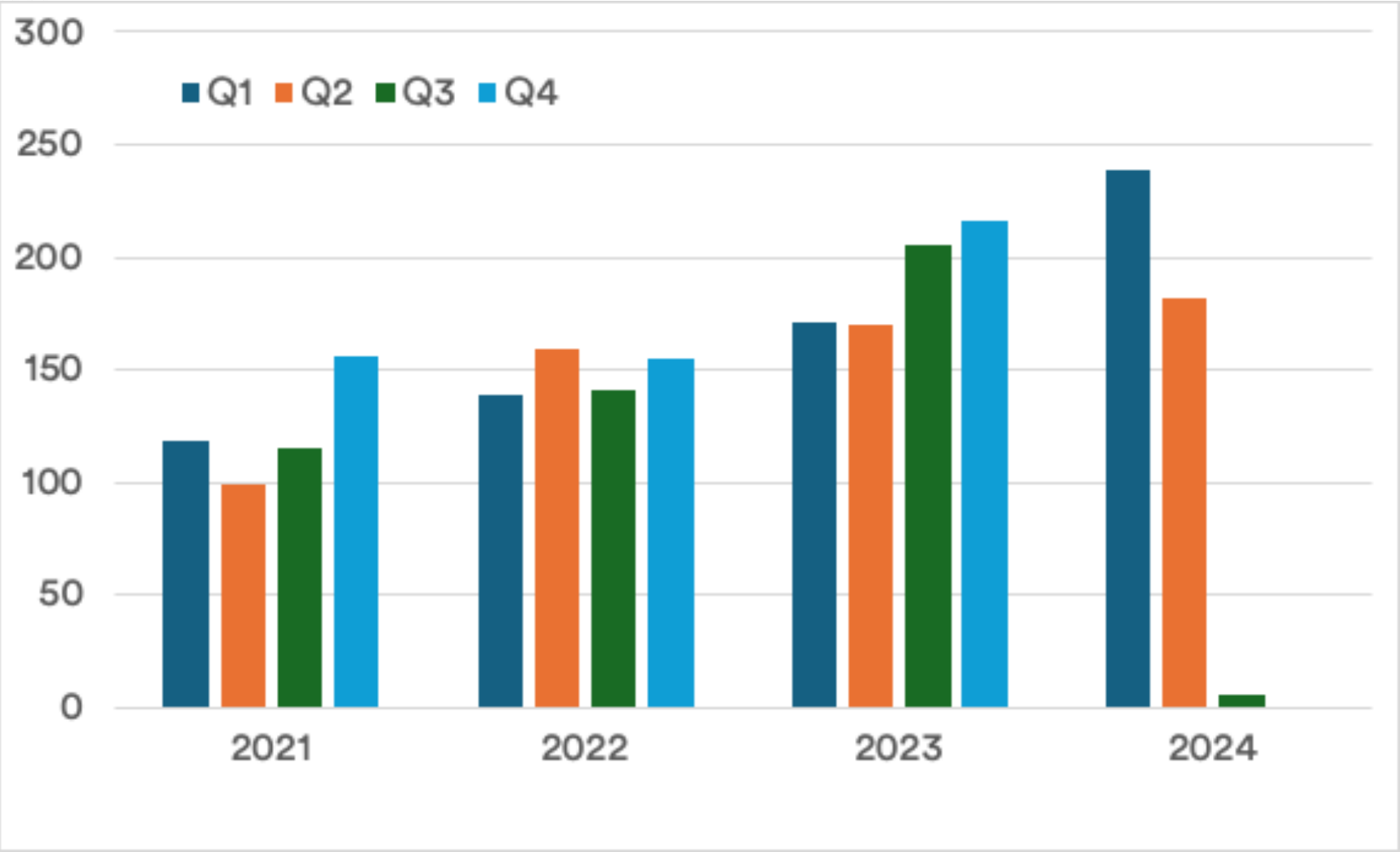
ASF Submission Times

(for ASFs submitted from January 1, 2021 – June 10, 2024)



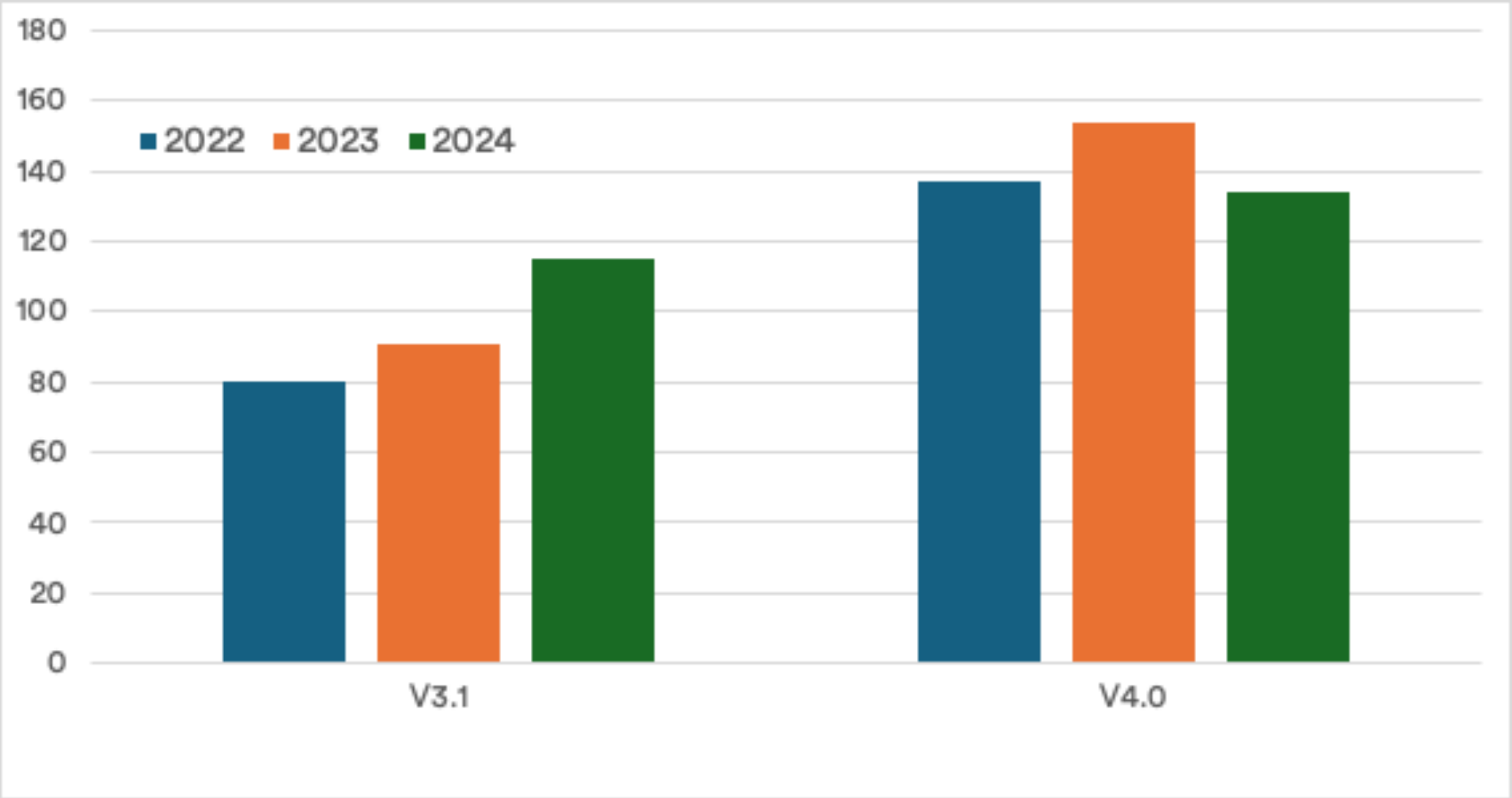
Extensions Trend

(since January 1, 2021)



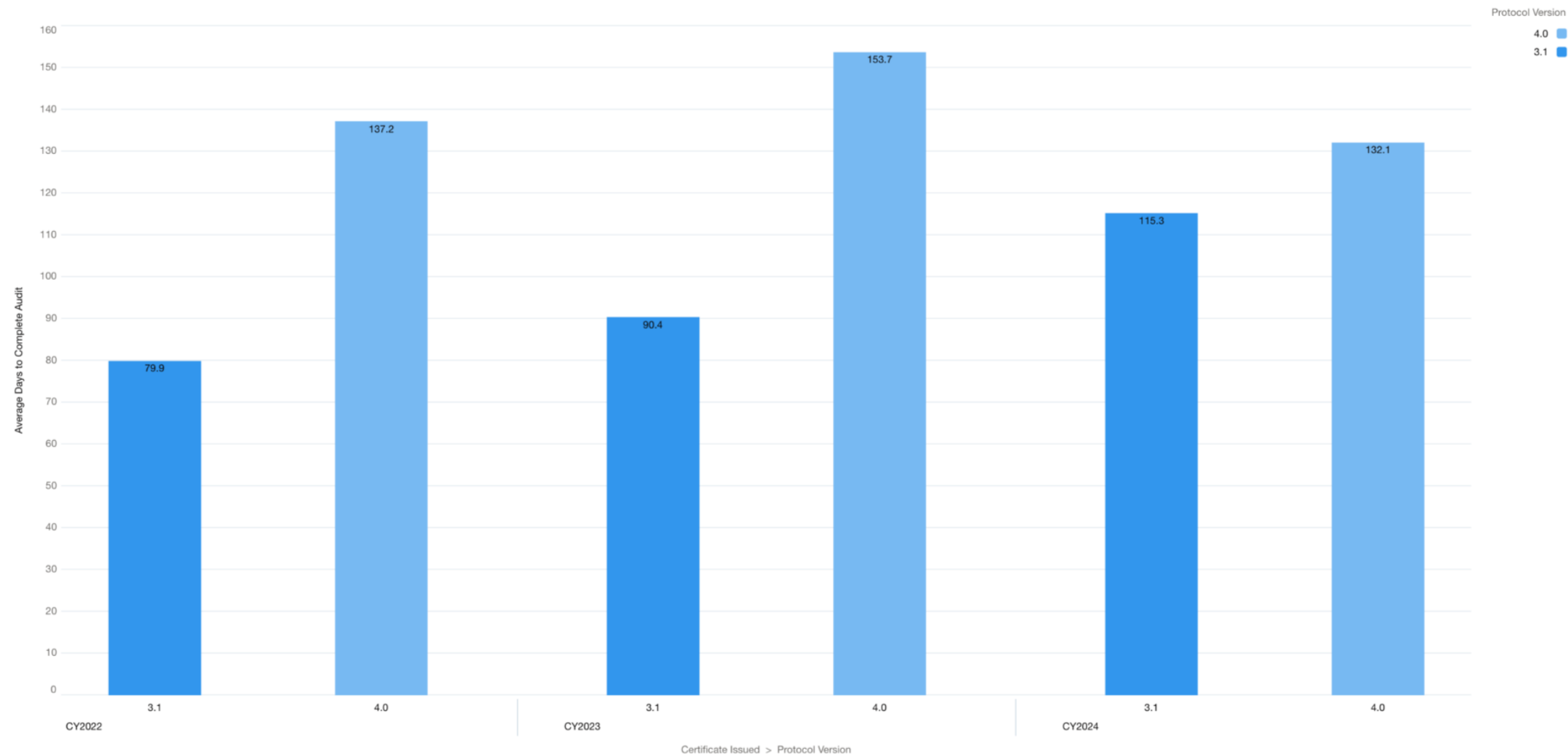
Time it Takes to Complete Certification Review

Current ASF quality issues

- Administrative inconsistencies:
 - Files mentioned in the ASF cannot be identified in the supporting documentation as they may be absent or have a different filename. Examples include the citing of RSL declaration names in the BOM
 - Make sure the information on applicant company, product name and submission date is consistent across tabs "Instructions" and "Admin" (This info will be removed from "Instructions" tab in the V4.1 AS)
 - FMS process definitions: Make sure to list processes included in or excluded from the final manufacturing stage that differ from those listed in guidance and **rationale**. The latter is often not provided.
- Assessor explanations: be sure to complete these as requested, it helps speed up the review process by indicating where reviewers can find the relevant evidence

Current ASF quality issues

Products covered and product descriptions

- C2CP II publishes the content of the tab "Products Covered" on the product registry. If there is information that is not to be displayed on the registry, please either remove it or clearly mark it as confidential and not to be published
- C2CP II has to frequently correct product descriptions that are not created according the guidelines for product listings in the product registry. Be sure the product description aligns with these guidelines and work with the applicant to submit an eligible description.

C2CPH Actions & Next Steps

- Assessor training and practice assessment, including example ASF (completed in 2023)
- Risk-based ASF review approach (ongoing)
- One on one assessor calls to address problem areas (ongoing)
- Communications to cert holders/applicants (ongoing)
- Development of 'benchmark' Version 4.1 ASF to assist with reviewer consistency and effectiveness (ongoing)
- Digital platform with improved certification process (in development)
- Strengthening review capacity:
 - Training additional reviewers (ongoing)
 - Hiring new Certification Associates (ongoing)
- Version 4.1 updates to assessor training (Q3)

Requested Assessor Actions & Next Steps

- Start recertification process sooner so ASFs are submitted well before the expiration date and paid extensions are not needed
- Improve ASF quality
 - Follow instructions and ensure all requested information is included in each ASF
 - Ensure all standard requirements have been met and QA'ed before submission
 - Address all questions/requests for additional information in response
 - No partially completed ASFs or responses
- Inform clients about:
 - Certification process (C2CP II review of ASF needed prior to cert issuance)
 - Current review timelines [days]: V4.0: 74 (C2C), 37(MHC); V3.1: 32 (C2C), 40 (MHC)
- Take Version 4.0 assessor training and practice assessment (Updates for V4.1 available asap)

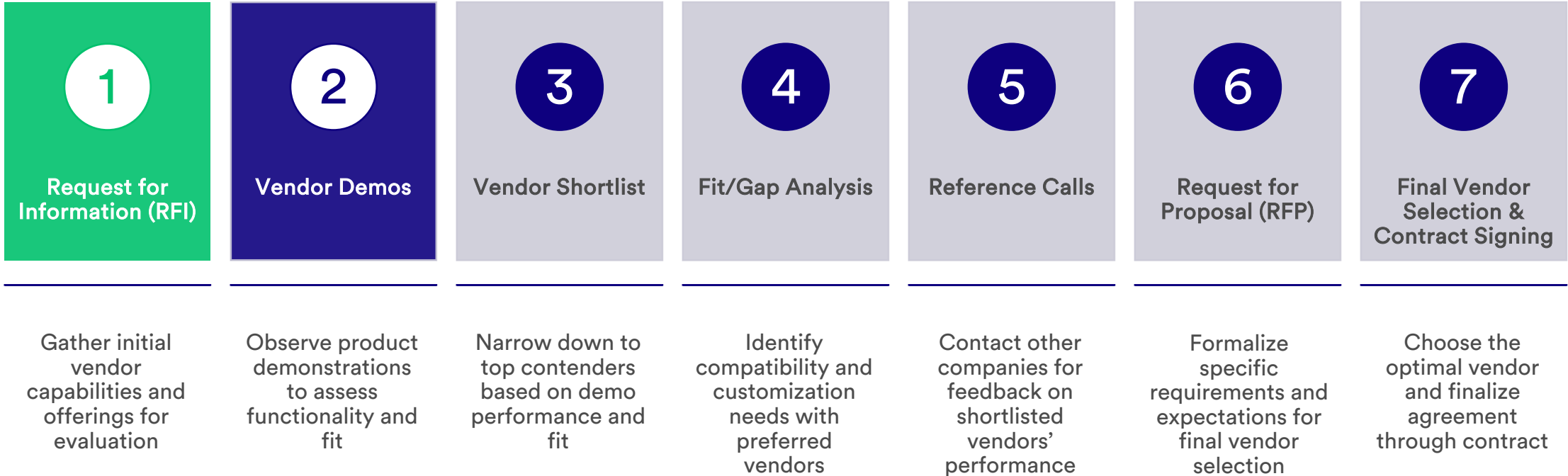

Version 4.1 Assessor Training

- Will be developed as quickly as possible after other V4.1 documents completed
- Online training modules, knowledge tests, practice assessment exercise will be required for all assessors by a deadline (TBD)

Updated Version 4 Transition Policy

- Please see updated policy on V4.1 page of the C2CPH website
- Companies may apply for certification to Version 4.1 beginning 1 July 2024 (the Version 4.1 Effective Date).
- Applications and Assessment Reports for certifications to Version 4.0 will be accepted until 31 December 2025. Applications and ASFs received after this date will be required to certify to Version 4.1.

Options for V4.0 to V4.1 Transition

Companies wishing to recertify their product(s) to Version 4.1 prior to their current Version 4.0 certification expiration date may do so via one of two ways:

- (1) Interim Assessment Review – An assessor must provide all updates in the V4.1 Assessment Report Form (additional information that needs to be provided for V4.1 is highlighted). The certification will expire on the date of the original Version 4.0 certificate. The IAR fee applies.
- (2) Early recertification – An assessor must submit a Version 4.1 Assessment Report Form following the same procedure used for a typical recertification, with all recertification requirements met. The recertification fee applies.

Hybrid Version 4.0 Certifications

- Similar to the policy for Version 3.1 "hybrid" certifications, certification applicants may certify to whole categories of the Version 4.1 requirements as part of overall Version 4.0 certifications to assist in the transition to Version 4.
- All requirements within a given category must be assessed against either Version 4.0 or Version 4.1. It is not allowable to certify to a mix of both Version 4.0 and Version 4.1 requirements within a single standard category.
- Please submit the applicable information in the Version 4.0 and Version 4.1 Assessment Report Forms

Version 3.1 to 4.x Transition Policy

Products currently certified to Version 3.1:

Recertification to Version 3.1:

- Product certifications expiring between 16 November 2022 and 31 December 2024 may recertify to Version 3.1 one additional time. (Note: The certification expiration date referred to is the original expiration date, not including any extensions)
- Assessment summary forms for these Version 3.1 recertifications will be accepted until 31 December 2024.

Should the policy be changed to add the following?

- Products certified to Version 3.1 for the first time after 16 November 2022 may recertify to Version 3.1 again if the ASF is received by 31 December 2024
- This may be done upon expiration or prior to the two-year certification ending (i.e., an 'early recertification')
