# 1 Purpose

This policy is intended to provide the conditions and procedures for private label product certification within the Cradle to Cradle Certified® Products Program.

# 3 Definitions and acronyms

**Certification Body (CB):** The Cradle to Cradle Products Innovation Institute (C2CPPI).

**Certification Scheme (Scheme):** The document that describes the functions, responsibilities, relationships, and processes for entities engaged in Cradle to Cradle Certified® product certification.

**Certification Scheme Owner (Scheme Owner):** The Cradle to Cradle Products Innovation Institute (C2CPPI).

**Certified Product:** A product that has achieved certification to a Cradle to Cradle Certified standard.

**Conformity Assessment Body (CAB):** An entity authorized by the C2CPPI to conduct assessments sufficient in scope and rigor to support a certification decision based on the Cradle to Cradle Certified standards, in accordance with the requirements of ISO/IEC 17065.

**Cradle to Cradle Certified Product Standard (the 'standard'):** The standard that serves as the basis for all Cradle to Cradle Certified® product certifications.

**C2CPPI Certification Agreement:** The legally binding and enforceable document that identifies each party's obligations and responsibilities, legal considerations such as

length of term, indemnification and liability, and certification services and activities including the use of trademarks, logos, and intellectual property of C2CPH.

**Fees:** Certification program fees charged by C2CPH that are separate from CAB fees.

**Original Equipment Manufacturer (OEM):** The producer of a product that has achieved Cradle to Cradle Certified certification.

**Private Label Entity:** The entity that sells a Cradle to Cradle Certified product under a brand name different from the one used by the OEM.

**Private Label Product:** A product identical in every way, except for brand name and packaging, that is produced using the same materials and processes in the same facility as a Cradle to Cradle Certified product.

## 4 Applicability

This policy applies to the producers of Cradle to Cradle Certified products and any entity that wishes to sell a Cradle to Cradle Certified product under a brand name different from the original certified product.

## 5 Conditions

### 5.1 Qualification

An OEM must demonstrate to the Cradle to Cradle Products Innovation Institute (C2CPH) that a proposed Private Label Product meets the requirements for the inclusion into the scope of the certification for a specific product. In order to qualify, the product must be identical in every way, except for brand name and packaging, to a Cradle to Cradle Certified product. This product must be manufactured in the same facility, using the same materials and processes as the certified product.

### 5.2 Packaging

5.2.1 To include packaging in the scope of certification, one of the following shall be demonstrated:

- (a) The Private Label Product's packaging uses the same materials (and no other additional) as the OEM product's packaging, and packaging is included in the scope of the OEM product certification, or

(b) A CAB has assessed the Private Label Product's packaging and made a certification recommendation, which is accepted by C2CPH.

5.2.2 If the packaging of the Private Label Product cannot be demonstrated to conform to the certification requirements via 5.2.1, such packaging shall be excluded from the scope of certification.

5.2.3 No exclusion shall exempt any packaging from meeting general packaging requirements of the Cradle to Cradle Certified standards.

## 5.3 Terms of Certification

5.3.1 Provided the terms of private label certification are met and payment of fees remains current, private label certification continues throughout the duration of the OEM certification period.

5.3.2 Regardless of the date a Private Label Product certification is granted, the private label certification shall expire on the same date as the OEM certification containing the Private Label Product in its scope of certification.

5.3.3 Private Label Product certification may be withdrawn for reasons solely in the domain of the Private Label Entity, such as non-payment of fees, or failure to adhere to the terms and conditions of the C2CPH Certification Agreement, or any action deemed by C2CPH to be detrimental to the mission and values of the Cradle to Cradle Certified Products Program.

5.3.4 Withdrawal of Private Label Product certification for reasons deemed by C2CPH to be exclusively in the domain of the Private Label Entity shall in no way affect the OEM certification.

## 5.4 Fees

5.4.1 Cradle to Cradle Certified Private Label Product certification shall be subject to fees set by C2CPH, as stated in the Cradle to Cradle Certified Products Program Fees Schedule.

5.4.2 Private Label certification fees are regarded as separate and shall have no bearing on the certification of OEM Cradle to Cradle Certified products.

5.4.3 Private Label Product certification fees for a period less than the full period of certification covered by the OEM certification shall be pro-rated accordingly.

5.4.4 Failure to meet payment terms of private label certification fees shall result in withdrawal of certification of the Private Label Product.

5.4.5 At the sole discretion of C2CPH, fees may be modified in individual instances of single use, or low volume limited use of a Cradle to Cradle Certified private Label certification.

## 6 Process

6.1 An OEM or private label certification applicant company indicates to C2CPH its intent to include a Private Label Product into the scope of certification.

6.2 C2CPH provides the OEM and private label certification applicant company with a documentation form to verify the Private Label Product meets the conditions for inclusion into the scope of certification.

6.3 Upon receipt of the Private Label Product verification documentation, C2CPH may elect to expand the scope of certification to include the Private Label Product.

6.4 C2CPH informs the OEM of its decision.

6.5 If approved, the C2CPH contacts the Private Label Entity with the necessary documentation, including a C2CPH Certification Agreement, for inclusion of its Private Label Product into the scope of certification.

6.6 Upon execution of the legally binding agreement to the terms and conditions of certification, and payment of appropriate fees to the C2CPH, the Private Label Entity may declare its Private Label Product to be Cradle to Cradle Certified.

## 7 Intermediary Agents

To the extent the Private Label Entity relies upon any Intermediary agent(s) (such as traders, brokers or distributors), all intermediary agents must complete and sign the Certificate Product Private Label Verification Form to establish a chain of custody and authenticity that the Private Label Product is the same as the OEM certified product.
